TIMING AND APPLICATION STRATEGY FOR OVERSEEDING SUCCESS

Timing	Product	Rate	Application Notes
Early May	Contrado	12–16 ¹ fl oz/A 0.28–0.37 fl oz/ 1000 ft ²	Post-application irrigation or rain of 0.1-0.2" is needed immediately or within 1-2 weeks to move the active ingredient to the root zone for control of white grubs and to allow for systemic uptake in the plant.
1-5 Days Before Seeding	T-Nex	Turf type- specific ²	Apply to suppress growth of established turf and allow light and space for new seedlings.
At Seeding	Taurus Trio G	87 lb/A 2 lb/1000 ft ²	Incorporate with overseeding for up to a year of fire ant control.
	Strobe Pro G	174 lb/A 4 lb/1000 ft ²	Incorporate with overseeding to prevent damping-off and patch diseases during establishment.

¹Application rates should be adjusted based on the anticipated length of the growing season. For longer seasons or applications made earlier in the season, use the higher labeled rate to ensure season-long control.
